Categories for this non-juried event are filled on a first-come, first-served basis 1) to emphasize the handcrafted talents of our region and 2) to avoid duplicates. All products sold must be made by the vendor. Subletting spaces is not permitted and, in this instance, the vendor will not receive a refund of fees. - Set-Up** After 10am Friday, May 22 or Saturday before 9am
- Hours** Friday, May 22, 5pm-dusk (Friday night is optional); Saturday, May 23, 10am-7pm or dusk (your choice)
- Fees** \$15 Non-Profit handcraft product vendor (i.e. churches, schools, 501c3 entities) – per 12’x12’ space
\$20 Art & Craft handcraft product vendor – per 12’x12’ space
